**OLD BUSINESS**

**Heating Update (if available)**

Mark Chalbeck reported that the Facilities Committee met. He said because the current heating system is a proprietary (Schneider) system it must be exclusively serviced by them or one of their representatives. A new system would cost \$25,000 - \$35,000. The Board will revisit this topic at their annual retreat.

Motion by Dana Buckley, seconded by Kristina Ickes, to approve the policies second reading/adoption, and the motion carried unanimously.

Policies BCA Code of Conduct, CHCA Approval of Handbooks and Directives, CM School District Annual Report, GBJ Personnel Records, IF Instructional Approach, IH Instructional Programs, IKA Grading System and JLCA Physical Exams of Students were in the packet for a first reading. Motion by Dana Buckley, seconded by Kristina Ickes, to approve the first reading of the policies, and the motion carried unanimously.

Resident Sam Martin (Chester Turnpike), asked the Board to be cognizant about going over the preventative maintenance contract because doing so can become costly.

Motion by Kristina Ickes, seconded by Dana Buckley, to enter into a non-public session under RSA 91-A:3 Section c. A roll call vote was taken. With all in favor, the motion carried.

The Board re-entered their public session at 6:53 p.m.

Motion by Dana Buckley, seconded by Kristina Ickes, to grant a waiver of Candia School District Policy JEB to the Tremblay family, and the motion carried unanimously.

Mr. Tremblay asked if they would have to be before the Board again next year, to which Bill Rearick stated they would not.
